STATEMENT OF FAITH

1. We believe in one holy and true God who works all things according to the counsel of His own will. In the unity of the Godhead there are three persons: God the Father, God the Son, and God the Holy Spirit. They are all of one substance, equal in power, glory, and honor. (1 Corinthians 8:14, Matthew 28:19)
2. We believe the Bible to be the inspired and inerrant Word of God, given as the rule of faith and life. (2 Timothy 3:16)
3. We believe that God created the world from nothing and is sovereign in its governing. God's intention is for man to subdue this creation and to live for the glory of God. (Genesis 1)
4. We believe that all men are sinners deserving of eternal punishment. (Romans 3:23 and 6:23)
5. We believe that God appointed His Son to suffer and die for sinful men, thereby receiving their punishment that He might be the only mediator of God's elect. It is in believing in Him that man comes to receive eternal life and be made a new creation in Christ. (John 3:16; 2 Corinthians 5:17)
